What matters to you in the Village of Marwayne? Is it our recreational spaces, the need for more activities for young people, the improvement of services for the aging population, the maintenance of our road network or ensuring that local businesses can thrive? If you answered yes to any of these questions, becoming a Councillor for the Village of Marwayne may be the right fit for you.

Councillors are elected to represent the residents of their local community. As a Councillor, you are tasked with making important decisions related to budgeting, infrastructure, economic development and much more. Being a Councillor is both a rewarding and privileged form of public service as you are in a position to make a difference to the quality of people's daily lives and ensure the prosperity of the place you call home. To be eligible to run for Council, you must reside within the municipal boundary of the Village of Marwayne and not have any outstanding monies owing to the municipality.

As a Councillor for the Village of Marwayne, you must: Consider the welfare and interests of the municipality as a whole and bring to Council's attention anything that would promote the welfare or interests of the municipality; Promote an integrated and strategic approach to intermunicipal land use planning and service delivery with neighboring municipalities; Participate generally in developing and evaluating the policies and programs of the municipality; Participate in Council meetings and Council committee meetings and meetings of other bodies to which they are appointed by the Council; Obtain information about the operation or administration of the municipality from the CAO or person designated by the CAO; Keep in confidence matters discussed in private at a Council or Council committee meeting until discussed at a meeting held in public; Adhere to the code of conduct established by the Council; and Perform any other duty or function imposed on Councillors under the MGA, any other enactment or by the Council.

The required forms to run for the office of Councillor for the Village of Marwayne are readily available by visiting our website at <u>www.marwayne.ca</u>, or in person at the Village administration office. All relevant paperwork must be submitted to the Village administration office in person by September 20th, 2021. The next general municipal election will be held on October 18th, 2021.

Be Aware of Bald-Faced Hornets

The Village of Marwayne has received multiple reports of the Prescence of Bald-Faced Hornets in the community. Bald-Faced Hornets are aggressive and will attack anyone or anything that invades their space. To date, they have been reported along the walking trails, near the ball diamonds and in residential backyards.

Bald-Faced Hornets inject venom with their stinger causing the area to hurt, itch and swell for 24 hours and can sting multiple times because their stingers are not barbed. We strongly advise residents to be aware of these hornets and exude caution when removing their nests. For more information on the species, please visit the link below:

Calling all Volunteers for our Lead Testing Program!

The Village of Marwayne is seeking volunteers to have the water from their homes tested for lead. Typically, lead levels in source water are very low and the finished drinking water produced at water treatment plants is virtually lead-free. However, lead can leach into drinking water from tin-lead solder, brass fittings and some water meters. Lead-containing materials were more commonly used in the past, and consequently occur more frequently in older homes. That being said, recent construction does not eliminate the risk of lead leaching into drinking water. As such, the Village of Marwayne is pleased to advise that we will be randomly sampling homes within the Village boundary for lead in order to comply with our mandate from Alberta Environment. If you would like to volunteer your home for sampling, and your residence meets the eligibility criteria, please email admin@marwayne.ca. Volunteers who meet the eligibility criteria will be contacted and forwarded the applicable paperwork and

contacted and forwarded the applicable paperwork and consent form to participate in the program. We thank all those interested however only twenty (20) homes will be selected for testing over the next two (2) year period.

The Village is in search of homes who meet the following criteria:

- Twelve (12) Single Family Units built before 1960
- Four (4) Single Family Units built between 1960 and 1975
- Two (2) Single Family Units built after 1975
- Two (2) Multi Family Units

CAN WE - "CREATE HOPE THROUGH ACTION" ?

September 10th is a day set apart by the International Association for Suicide Prevention as World Suicide Prevention Day. This day began in 2003, to be a world action of prevention and awareness in community and country. Stats indicate there are 3000 completed suicides a day world wide and 20 attempted. 1 in every 100 deaths worldwide is the result of suicide. 1 million completed suicides a year worldwide. That is 1 million too many.

It can affect every one of us. Each and every suicide is devastating and has a profound impact on those around them. However, by raising awareness, reducing the stigma around suicide and encouraging well- informed action, we can reduce instances of suicide around the world. By recognizing this day set aside, raises awareness, and will promote action through proven means that will reduce the number of suicides and suicide attempts globally.

'Creating Hope Through Action' is a reminder that there is an alternative to suicide and aims to inspire confidence and light in all of us; that our actions, do matter how big or small, may provide hope to those who are struggling. Preventing suicide is often possible and you are a key player in its prevention. Through action you can make a difference to someone in their darkest moments – as a member of society, as a child, a parent, as a friend, as a colleague or neighbour. We can all play a role in supporting those experiencing a suicidal crisis or those bereaved by suicide.

Suicidal thoughts are complex. The factors and causes that lead to suicide are complex and many. No single approach works for everyone. What we do know is that there are certain factors and life events that may make someone more vulnerable to suicide and mental health conditions such as anxiety and depression can also be a contributing factor. People who are suicidal may feel trapped or like a burden to their friends, family and those around them and thus feel like they are alone and have no other options. The COVID -19 Pandemic has contributed to increased feelings of isolation and vulnerability. By crating hope through action, we can signal to people experiencing suicidal thought that there is hope and that we care and want to support them.

REACH IN- You can help give hope by showing that you care. All of us can play a role, no matter how small. We may never know what we do that makes a difference. We all can reach in and ask somebody. You do not need to tell them what to do or have solutions, but simply making the time and space to listen to someone about their experiences of distress and suicidal thoughts can help. Small talk can save lives and create a sense of connection and hope in somebody who may be struggling.

ENCOURAGE UNDERSTANDING –**Stigma is a main barrier to help-seeking.** Changing the narrative around suicide through the promotion of hope can create a more compassionate society where those in need feel more comfortable in coming forward to seek help. We can all do something to live in a world where suicide is recognised and we can all do something to help prevent it.

SHARE EXPEREINCES – The insights and stories of people with a lived experience of suicide .

Personal stories of an individual's experiences of significant emotional distress, suicidal thoughts or attempt, and their experiences of recovery can inspire hope in others that they too can move through the period of distress or crisis and their insights can help others understand what it means to feel suicidal and how they can support others . In sharing the person sharing their story knows how to do so in a way that is safe for them and for those who hear their story. For individuals sharing experiences of being bereaved through suicide and how they came to live their 'new normal', can help others experiencing suicidal loss make sense of the devastation of suicide and believe they will be able to live through and with the loss.

By encouraging understanding, reaching in and sharing experiences, we want to give people the confidence to take action. To prevent suicide requires us to become a beacon of light to those in pain. YOU CAN BE A LIGHT!


